<sup>1</sup> Defendant Lawson originally had two cases for which he was committed to state prison. On January 13, 2015, the 36 month prison commitment for felony possession of morphine was vacated pursuant to Proposition 47, and a new sentence of 365 days in the county jail was imposed. As a result of that resentencing, defendant's second case (Line Item 41) needed to also undergo resentencing. The original subordinate state prison commitment of 16 months consecutive was vacated and defendant Lawson was resentenced to 44 months in state prison on this remaining felony case. The net savings to the defendant granted to him by Prop 47 is 4 months actual prison time.
