<u>Mendocino Behavioral Health Advisory Board Kemper Report Response</u> Recommendations

- 1. Section III, line 5: MOUs will meet a 90 day target, as recommended in Kemper Report.
- 2. Section III, line 1: a) A contract manager to oversee financial claiming and service delivery outcomes. b) A program manager to work with the clinical side and directly with the behavioral health and service delivery director to assure coordination of administration and clinical oversight, and review all facilities.
- 3. Section IV, line 1: Meet the recommendations to hold the public forums specific to residential care and crisis residential services.
- 4. Section IV, line 2: Ensure the MOU and 5150 Review happens within 90 days, and develop and implement an arbitration process for psychiatrists, ASOs, hospitals and the County.
- 5. Section VII: An outside independent financial audit will be conducted of both ASOs contracted services
- 6. Section VI: Renewed spirit of openness and transparency with the Behavioral Health Advisory Board.
- 7. Section III, line 4: Electronic health records will be ready to implement by both ASOs with the County by July 1, 2016. 8. Section IV, line 5: Formalize and finalize contracts for 18-24 year olds (TAY) services and transition with both ASOs.
- 8. Section III, line 6: Clarify definitions for ASO administration, direct men-tal services, and utilization review and proposed methodology for deter-mining payments for these activities.
- 9. Section VII, line 1: Present quarterly financial summary reports, all inclusive, to Behavioral Health Advisory Board.

Also Board's recommendations:

- 1. A monthly report will be provided to the BHAB from the CEO and BOS on the status of the Kemper recommendations.
- 2. We recommend the County apply for the peer respite grant due March 8, 2016. This follows in line with Kemper's suggestion that we look to increasing seeking additional funding. In consideration of residential care and crisis residential services, also address the imminent need to use the \$500,000 wellness grant that has a deadline.
- 3. Prioritize recruiting and hiring credentialed case managers
- 4. Prioritize and provide necessary resources to hire a full time County psychiatrist.
- 5. Credentialed 5150 card holder staff able to respond in all outlying areas within 25 minutes.
- 6. Talk-therapy and persistent follow-up for those who are discharged from mental health hospitalization.
- 7. Ensure there is a fully staffed Substance-Use Disorder Treatment department. Provide integrated co-occurring disorder treatment.
- 8. Create and Implement Mental Health Crisis/Respite and Substance-Use Disorder Treatment Detox Centers inland and coast.
- 9. Recommend employment of a full-time Assisted Outpatient Treatment Program Coordinator for Laura's Law pilot program.
- 10. Board of Supervisors form the ad-hoc committee at the BOS level to track the implementation and management of the Kemper Report's recommendations, and ensure board member involvement in the process.
- 11. There was a lack of review, comment or inclusion of Latinos in the Kemper Report.
- 12. Implement the recommendations from the EQRO (External Quality Re-view Organization) Report to increase the penetration rate for the county Latino population.

- John Gilmore stated he had concerns about the RFP and time frame
- Jan McGourty- thought 90 days is too short, 120 seemed more responsible
- John McCowen 120 county vs 90 days as the Kemper report recommended. Advocated that the County work with the ASOs, verse bringing in new providers. Also dual tracks at the same time, which would be the county working with current ASOs so that ASOs could accomplish the recommendations of the Kemper report and also developing RFPS at this time. ASOs needs to focus on developing MOUs with agencies.
- Carmel Angelo- BOS will be giving us directions.
- Kate Gaston- 2017 is a major problem with MOU. MOUs need to be done in a shorter time period and the need to hire a contract specialist to oversee MOU and contracts
- John McCowen –The county needs to meet the recommendation of the Kemper's report, maybe outside consultation to implement and oversee, and a contract administrator to negotiate MOU and give guidance with contracts to BOS and mental health board.
- John Wetzler- can Lee Kemper help?
- Carmel Angelo- Lee is looking for people who could help, maybe someone he already works with.
- John Wetzler- once a person is hired, time line may change?
- John McCowen- this position will be administrative and will do oversight of the contracts including fiscal
- Carmel Angelo -Contractor maybe bigger than just a contract administrator, possible project manager and contract manager. MOUs maybe difficult between ASOs and agencies, so mental health director will be at the table to help with the MOUs.
- Margie Handley- What about looking at other counties who have been successful with contracts for guidance?
- Carmel Angelo- this may be difficult because Mendocino County has contracted out most of the mental health services, does not know of any other county that has contracted out so many services
- Jan McGourty- Could County Counsel be a resource for the MOUs and also people of the board.
- Roger Schwartz- Thrilled by the Kemper report, what he is concerned about is the effort, and the money.
- John McCowen. There should not be any extra costs. There should also be a follow thru with Crisis residential plans.
- Jan McGourty- what about the cost of additional staff
- John McCowen- 85% is covered by billing.
- Roger Schwarz- the CEO executive staff will be following thru with this?
- Carmel Angelo-Agency vacancies rate is very high, which will cover the cost of staff needed. \$100,000 for the position.
- John McCowen- this has to be a priority
- Dina Ortiz- will general funds be used if needed.
- John McCowen- Yes
- Roger Schwartz- this is what I like to hear!
- Kate Gaston- there should be two positions, project manager and project coordinator

- John Wetzler.- \$100,000 seems very low for those positions-
- Dina Ortiz- maybe if you raised the salary, the county could hire better qualified persons.
- Nancy Sutherland questioned the vote of confidence.
- Jan McGourty-The time frame of June 1^s is goodwill, but look at Laurel's Law and the timeframe. Keep with Kemper's dates.
- Lois Lockart- point of budget contract with fed and state, the Grief act of 1963. There is a Fed and State criteria of time frame that has to be met or money is taken away.
- John McCowen-Since no money has been taken away, I am assuming that the county is doing "ok". With the RFP if new ASOs maybe destructive to start over. There is already a foundation, work with it.
- Emily Strachan- Time frame, maybe there needs to be more time, if not will there be more failures.
- Roger Schwartz- Progress reports at Board meetings to monitor timeframe. Let it be on the agenda permanently.
- Kate Gaston- I like what Emily said gives them time with a dead line.
- Lois Lockart This is what contract management is about.
- John McCowen- does anyone have appointments after 3:00 pm because this is very important. Recommendations need to be solid and transparent. We need to take advantage of this time.
