CALL TO ORDER

The meeting was called to order at 4:08 p.m. Committee members present were: Jan McGourty, Jacque Williams, Lois Lockhart, Kate Gaston, John Wetzler, Margie Handley, and Donna Moschetti. Guests present were: Dina Ortiz, Nancy Sutherland, BHAB. Tim Schraeder, Camille Schraeder, and Chandra Gonzales, RQMC. Mary Alice Williford and Doug Gherkin, County financial staff.

WHAT WE KNOW ABOUT THE MENTAL HEALTH BUDGET

Jan stated that Mental Health services are contracted out and information has been difficult to get from the County HHSA Department and the ASOs.

WHAT WE NEED TO KNOW ABOUT THE MENTAL HEALTH BUDGET

Members of the Finance Committee stated their questions and concerns (see attached). Then staff from RQMC and the County offered their knowledge and presented more complexities including TAR (Treatment Authorization Rate), 134 account at the State level, leveraging with base amounts and limitations.

ACTION PLAN FOR THE NEED TO KNOW

There was a consensus that we all need to have a common understanding of these issues. It was agreed that in order to develop this common clarity of understanding, the Finance Committee will recommend that the BHAB sponsor a joint training by RQMC and County finance staff in late August to get everyone on the same page. In the meantime, we are recommended to attend the County's budget workshops to gain a deeper understand of the budget in general; dates are posted on the County website.

- Are Medi-Cal billings included in contract amounts?
- How is Medi-Cal billing broken down?
- What is the cost of hospitalizations and how are they broken down?
- What are the different certifications of hospitals and do they differ in cost?
- Is there a breakdown by ethnic?
- What are the hospital resources available? We need a list.
- What is the County spending at the jail on MH services?
