List of Qualified Site Evaluators:

Unless your system consists ONLY of a clothes washing machine, a Site Evaluator will need to do soils analysis at your site and design your system.

Fee Schedule:

For systems larger than a clothes washer system, Environmental Health charges both a Site Evaluation Report Review Fee and Permit Fee.

Regulations:

Graywater regulations are located in Chapter 16A of the CA Plumbing Code.

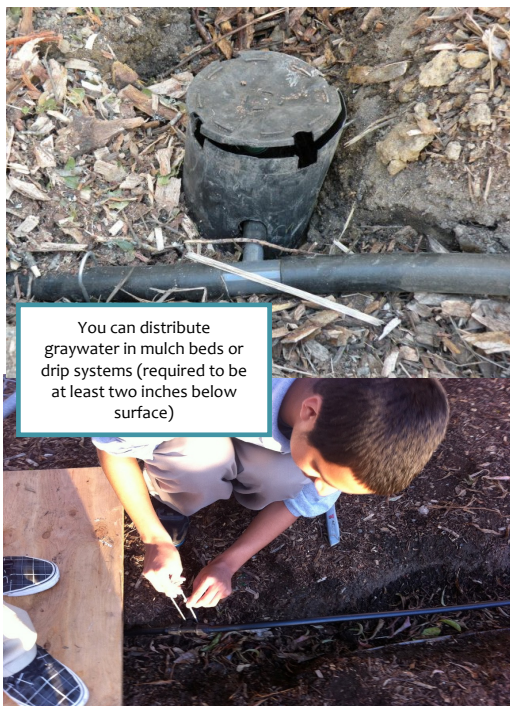

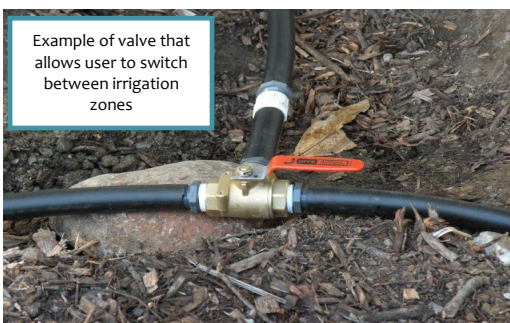
Example of clothes washing machine valve which is required to switch between your new graywater system and your sewer / septic

1 Introduction

Recent changes to Chapter 16A of the California Plumbing Code have created new ways for you to use your graywater. Mendocino County Environmental Health has created this brochure to introduce you to the code changes and our permit process. It also describes when a permit is not required and is a great resource for detailed guidance documents.

Do you REALLY know what graywater is? Graywater is:

- Water from your clothes washer (unless it's used to wash baby diapers)
- Water from your bathroom sink and shower / tub

Graywater is not:

- Water from your toilet
- Water from your dishwasher or kitchen sink

It is important to note that although graywater is not as dangerous as black water, it still contains many bacteria and viruses. Because of this, graywater is only allowed to be captured and used in specific ways. Also, a septic system or sewer connection is still required. Please note that the use of a graywater system does not affect sizing criteria for septic systems. See Section 3 of this brochure for our website as well as other important resources.
