¹⁹ Penal Code section 140(a) denotes a felony conviction for threatening a witness who provided assistance to law enforcement and the prosecutor in a criminal proceeding.

²⁰ Health and Safety Code section 11378 denotes a felony conviction for possessing methamphetamine for purposes of sales.
