As the covid situation is rapidly changing daily, I want to make sure the board understands that our request for approval is not our only consideration or hurdle and there is a possibility that we will not proceed with the 2020 Labor Day weekend portion of our application. We have made significant changes to our service protocol in consideration of the pandemic including:

*Assigned seating to keep arriving parties in their social bubbles

*Limited seating with CDC distancing (less than 100 patrons per show down from 400)

*Separate entrance and exit with hand free sanitizer at both

*Required masks with signage

*Wallings of the tent will be kept up with fans pulling air out of the tent to maximize the 'outside' feature and reduce danger of aerosols

*Concessions served from enclosed trailer with service windows and plexiglass installed

*ground markings for cdc distancing at entrances and selling points

*staggered entry on tickets to limit cluster arrivals

*Separate showings for adults only and families

*Sanitation of all surfaces between and before each showing

*Staff quarantined prior to event and practising all CDC guidelines

Despite organizing a strong safety procedure, we will need other permissions beyond the MHRB, namely the entering into a stage 4 reopening and the allowance both by the County and

State for live events. At the moment, these allowances look like they are

not on track for our 2020 timeline. The epidemic is modeled to

pick up speed in the weeks ahead and could affect our business sector. We will

continue to monitor the situation and hope for a better outcome

Regardless of the trajectory, Flynn Creek Circus will need MHRB approval for 2020 and

future years in the application in order to plan. We have no intention of pushing against state and county guidelines should the situation be as tenuous as it looks like it is trending. We want to keep

our patrons safe and our public image intact. Our application stands as an optimistic first step.

We are currently leaning toward not hosting the 2020 event. Despite organizing a strong safety procedure, we will need other permissions beyond the MHRB, namely

the entering into a stage 4 reopening and the allowance both by County and State for live events. At the moment, these allowances look like they are not on track for our 2020 timeline. Regardless of the strength of our limited seating, open air and sanitation plan, the epidemic is modeled to pick up speed in the months ahead will affect our business sector. We will continue to monitor the situation and hope for a better outcome. I am concerned that we may receive a denial from MHRB due to covid concerns that will affect our application for future years' events. Would it be appropriate to let the board know in advance of the meeting that we are waiting on additional approvals and better ground conditions before executing the 2020 event, but regardless need MHRB approval for 2020 and future years before proceeding? I hope this makes sense. It feels a little hard to convey. Basically, we have no intention of pushing against state and county guidelines should the situation be as tenuous as it looks like it is trending.
