- Action Network Outreach April "child abuse prevention month" event Javier to send flier to Dennie electronically email the opportunity to Stakeholder list
 - Requested BHRS presence at the Cinco De Mayo event in Gualala on May 3rd will send flier to Dennie electronically – email the opportunity to Stakeholder and add to May event calendar
- Joy Kinion: Project Grant / Mobile Outreach Prevention Services (MOPS)
 - Grant requirements of this position: to go to a non-city policed area and to know the area and the culture
 - Takes referrals visits people in their homes by appointment and links them to services also to stop recidivism to stay stable
 - JAG Grant contact is Teresa @ the jail
 - Sheriff Allman's Grant provides a Tech employed by the Sheriff's Dept. who does not have arrest privileges or carry a gun to accompany her, and a vehicle the Tech will assist in deescalating situations – a Release of Information form is signed by the potential client when the Tech is present
 - Majority of referrals are coming from Probation due to Prop 47 over 63 people released from jail since January 2015
 - Time response depends on her location in the county when she is called and how severe the situation is
 - Age range: 18 and above
 - The Program is not under Laura's Law
 - Currently contacted 9 people
 - o Joy also participates as Search and Rescue for the county
 - Officer Stefani/Mendocino County Coastal Operations Officer
 - The station is not staffed and no answering machine officers are on patrol and a message states to call the crisis number
 - CHP meeting every 3rd Wednesday
 - o Quarterly Forum is in July

- Call the Sheriff Deputy's like they are just around the corner majority of the calls are from Albion to Fort Bragg
- Asked: Is there a way to know the seriousness of a call? Answered: It is a challenge to determine is it truly is not necessary to send a Deputy
- Witness a domestic dispute against the law to record it
- Welfare checks to send a Deputy is determined by the circumstances and history
- Recruiting for the south coast continuously
- Note: Private Foundation link through Sheriffs' website Public Safely Foundation
 - Sage Wolf / Stepping Stones Program Redwood Community Services:
 - Ages: birth, foster care to 25
 - Services: mental health therapy rehab, foster care, drop-in centers for teens at the Arbor in Ukiah (15 25) and the Anchor coming soon to Fort Bragg;
 - □ groups daily, cooking classes and independent living skills, peer support job skills class, job tutoring,
 - Stepping stones program services 18 25 transitional housing for youth in foster care and young adults with mental illness through Full Service Partnerships (FSPs) through the county and then eligible for the housing program
 - TAY Wellness apartment living (2 bedrooms/roommates) 2 year program 11 apartments
 - Gibson House supportive group living with 5 beds transition from long term hospitalization or who or in the process of getting SSI approved and have a mental illness and need a higher level of care – no time restriction on length of stay – staff support from 9am -10pm
 - Within the Housing program clients receive a stipend towards food and utilities, plus therapy and case management and can access the FSP funds for special circumstances like College classes or a bus pass that would help them to overcome the barriers to improve their life
 - Have not received referrals from south coast
 - FSP qualifications is case by case: impairment to functioning independently provided for a period of time on a case by case basis – to help their strength and resiliency to function independently
 - Undocumented youths cannot be FSP they are not Medical eligible (unless dying or pregnant) which is a requirement to be an FSP – check with Joy for possible fit for linkage in her program
 - Arbor Event Thursday Prom Night boutique from 4:00 6:30

- Laura's Law- the intention is to implement Laura's Law on July 1st an assisted, assertive, outpatient treatment for those with severe and persistent mental illness who are challenged with functionality and not currently receiving services, frequently in jail or hospitals, as an opportunity to live in the least restrictive setting and receive intensive treatment that may be necessary.
- Anyone who calls the Access Line who is 24 or under is referred to ICMS
- MHSA Workforce Education & Training (WET) program loan assumption program to pay back student loans requires a1 year commitment to provide mental health services of that qualifying candidate to retain the workforce in the county.

- CPS drug treatment follow through drug alcohol treatment in Pt. Arena
