- Oct. 5 11 Mental Health Awareness Week
  - Each Mind Matters website for details
- Joann Olson/MCYP: Received PEI funding for destigmatization and Anti-Bullying education in most school districts in the County
- Susan Bridge-Mount: Sr Peer Counseling has 4 new volunteers
- Mark Montgomery/OMG: ICMS has moved to 564 Dora St. in Ukiah and opened a satellite office at 524 Main St. in Fort Bragg
- Wynd Novotny/Manzanita: in partnership with Buckaloo offering Voc Rehab support, and in partnership with a MCOE grant to offer Mental Health 1<sup>st</sup> Aid Training on November 17<sup>th</sup> & 18<sup>th</sup>
  Covelo wants training flier, (emailed to Otis Brotherton and Helen Falandes)
- Dan Anderson/Tapestry: offering flexible services in Laytonville and Covelo, providing blocks of time with a therapist in both rural communities
- Sage Wolf/Arbor: TAY wellness housing went from 9 beds to 16 (ages 18-24) at the Gibson House for FSP Mental Health clients.

### 3) Recommendations for Future MHSA Services

Needs List Flier: feedback from consumers who attend the MHSA Forums:

- Consumer and family member panel to hear life experiences for informative discussion in developing solutions and support
  - o Stipend for presenters of their life experiences to the panel
- Transportation in rural areas: make bus passes more readily available and publically accessible
- Housing barriers: destigmatization education around mentally ill to Landlords and the community
  - TAY transitioning from Gibson House to an apartment is challenging in finding Landlords willing to rent to them
  - To access Donna and Sherry at Manzanita you must be an Access Client
    - Other resources: Katherine Kelly 260 Hospital Dr, and Rural Community Health Center is taking clients
- Extended Foster Care Programs
- Protection of rights with law enforcement

- Housing for pregnant homeless mothers
- Homeless safety 3 tickets for sleeping on private property is a Felony
- Matches for Shelter + Care: Looking for funding for those who don't qualify for specialty services to have support for filling out matches and the associated paperwork

## 5) Round-up and Next Steps

- MHSA housing component: legislative changes happened this week to allow small counties to access the funds more easily and will go into effect January 2015.
  - The intent of these funds is for permanent, stable, supportive services
  - o For FSP intensive level case management
  - o For 24-7 crisis resolution
  - Long term care
  - o Conservatorship
- MHSA Loan Assumption Program:
  - o Grad level degree repayment for loans in Public Service field
  - o Loan Requirement: 2 year commitment working in the community
  - Applications will be accepted October 13th to November 30th
  - This program helps to pay back a student's loan up to \$10,000
  - Contact Robin for details
- MHSA new requirement "Issue Resolution"
  - o Being developed and will be made available at every MHSA Forum
- Community Housing Forum Team Mark Montgomery attends meetings
  - Ad-hock Committee group
  - City decides their approach to homelessness
    - Ticketing the homeless who sleep on private property
  - City Council meetings Wynd has the dates
    - Public has 3 minutes to voice their concerns to their publically elected officials
