- Lawrence Lazaro/ Arbor: Grant-hired an employment Coordinator and Employment Specialist and developing plans. 15-24 ages.
 - o Transforming the Arbor to fit the needs of employees
 - o Teen Peer Program is going strong
 - o Applying for the drug free MediCal Grant
 - o CH3- access the public health food, advertising in stores, healthy items at the checkout stands, working on getting a public garden started
 - o Holiday parties Thankfulness Feast on 11/26/14: food donations are welcome
 - Andrew/Residential Advisor for the Gibson House: 6 bed facility 18-24 who come from out of county hospitals to develop living skills to transition to a lower level of care (just down the street from the Arbor)
- Sage Wolf/Arbor: TAY Housing 11 mental health beds, Gibson House is a supportive program clients can use between 18-25 years old, FSP to qualify, 23 current FSP's approved in the County and 10 are housed in the program. 13 FSP's remain at various levels of engagement. One opening will be filled in a week.
 - Expanding the community landlords that they work with, reducing the stigma around mental health illness – RCS developing a relationship with the landlords to provide references for the youths.
 - o Newly established partnerships are going well
 - ☐ Transition youth age services age up to 25 for case management in collaboration with Manzanita, MCAVHN & Tapestry
- Susan Bridge-Mount/Senior Peer Counseling:
 - Peer Counseling is for older adults, like Grandparents, are likely candidates working with seniors, trained to become para-professional counselors and see clients in their homes once a week. These clients deal with isolation, health, some substance abuse and emotional issues where transportation is a challenge. Serve Spanish speaking seniors.
 - o All clients have a treatment plan that is client developed
 - Meetings and on-going trainings for Senior Peers
 - Sargent Brandon Lee will be facilitating a training next week regarding a Scam targeting seniors
 - o Senior Center serves approximately 200 lunches per day many on-site trainings are facilitated there emotional support around the Holidays
 - o 20 clients, 4 new trained volunteers (ages 60-89)
 - o Clients must be sober to speak to a Peer Counselor
 - 5 clients in Sherwood Oaks Nursing Home in Fort Bragg
 - Collaboration with Hospice
