RCS	Stepping Stones is housing two young adults right now (Emergency). The Sunrise Inn is working with RQMC for housing (temporary). Anderson Valley now has a therapist with 6-7 youth clients. Fort Bragg office is looking for more office space.			
Tapestrey	In Process of becoming accredited.(7 therapists) PCIT is off the ground and being booked.(15 slots filled) Spanish speaking therapists have been hired. Therapist does one day in Laytonville, one day in Covelo, and three days in Willits.
