Response to FINDINGS

<u>Finding #3:</u> The percentage of students who transfer in from outside the District is between 20% and 25% (not 15% and 20%).

<u>Finding #8:</u> ROP classes offered include: Computer Technology (Graphics and Animation, Desktop Publishing) and Theater Technology.

The District offers and funds the following: Wood Shop, Photography, and Computer Programming.

Response to RECOMMENDATIONS

Recommendation #1: Mendocino High School has put a lot of effort into finding the best way to serve lunch to students. This has been the subject of much study over the past 5 years. Based on the surveys, research conducted, and the consultation of a nutritionist, lunch service was moved from the cafeteria to the hallway. In addition, meal offerings were updated and improved based on input from all stakeholders. More meals are purchased now than before the study on the program was undertaken. This is seen as confirmation that the study provided valid recommendations regarding lunch service and lunch offerings.

It should also be noted that Mendocino High School has an open campus and most of the students go off campus to purchase their lunch in town. Local merchants have worked with the District to provide student-friendly lunches, as the District recognized that students greatly preferred to leave campus during lunch. It is very hard to compete with commercial vendors not restricted by the mandates of the school lunch program.

Mendocino High School will not be changing its current lunch program, but will continue to monitor it and make changes and upgrades.

<u>Recommendation #2:</u> The elevator will be thoroughly cleaned this summer. In addition, maintenance and custodial workers have been notified of this finding and will monitor the cleanliness of the elevator more closely.
