The following Recommendation #8 have been implemented and a summary describing the implemented actions:

8. Point Arena High School ensure that all circuit breaker panels are closed and locked.(Finding 43)

District Director of Grounds and Maintenance will ensure that staff secures all access doors to circuit panels.

The following Recommendation(s) have not yet been implemented, but will be implemented in the future, **attached, as required** is a time frame for implementation

The following Recommendation(s) require further analysis, and **attached as required,** is an explanation and the scope and parameters of the planned analysis, and a time frame for the matter to be prepared, discussed and approved by the officer and/or director of the agency or department being investigated or reviewed: (This time frame shall not exceed six (6) months from the date of publication of the Grand Jury Report)

 The following Recommendations #'s **3,4,5,6,7,9** will NOT be implemented because they are not warranted and/or are not deemed reasonable, an explanation follows:

3. Point Arena High School implement a summer school immersion program for ESL students to accelerate their ability to function In English. (Findings 17, 24-25)

This recommendation has a fiscal impact and in the current fiscal crisis is deemed unreasonable.

4. Point Arena High School post bi-lingual directional signs to the school's main office. Ensure that postings are clear, visible, and sufficient to guide visitors. (Finding 18)

This recommendation has a fiscal impact and in the current fiscal crisis is deemed unreasonable.

5. a campus program to treat drug and alcohol problems be initiated at coastal schools.(Findings 35-36, 38)

This kind of program is clearly in the jurisdiction of the County of Mendocino and is outside the mandate of k-12 education.

6. Point Arena High School update the computer hardware and software for the computer lab. (Findings 8, 29-30)

This recommendation has a fiscal impact and in the current fiscal crisis is deemed unreasonable.

7. Point Arena High School request donation of books and resource materials for the school library with a series of articles in the local newspapers. (Finding 30)

The High School does solicit support for Library resources including partnerships with the local book store. In addition the Library has received a number of donations from community members. It is the Districts belief that further solicitation is unnecessary.

9. Point Arena High School have a gas company inspector determine if the stove is properly vented. (Finding 42)

The Cafeteria Kitchen was recently remodeled using State Modernization funding. All work was done under the direction of a licensed Architect and Inspected by an IOR. All installations were done according to DSA approved plans. The District Director of Food Service and the District Director of Grounds and Maintenance have inspected the stove and have found no evidence of propane odor in the kitchen area.
