The retrial resulted in a jury split that was the exact opposite -9 not guilty to 3 guilty. The defendants were ordered back to court on November 13, 2020 for further proceedings. However, because of pandemic concerns in the Ukiah courthouse, that November 13<sup>th</sup> date cannot happened and a new date will be scheduled.

 $<sup>^{2}</sup>$  Given the facts that defendant was originally charged with a felony, that the jury returned a guilty verdict on the lesser included misdemeanor, and the resulting jail sentence was nevertheless roughly equivalent to a 24 month local prison sentence, this result is now counted and weighed as a <u>draw</u>.
