Explanations for Recommendation:

Implemented Recommendations:

#2 The Fort Bragg Police Department does provide training to School Resource Officers (SROs) prior to their assignment. Currently, there are two Police Officers trained to function as a SRO.

Recommendations Not Implemented:

- #1 The Fort Bragg Police Department currently has two bi-lingual (Spanish speaking) officers. The Fort Bragg Police Department has proactively partnered with our local college to provide Spanish courses to our employees. In addition, officers will be enrolled in an Emergency Services Spanish Course which will further assist them in serving our Latino Community. The Fort Bragg Police Department will continue to recruit qualified minorities.
- #3 The Fort Bragg Police Department may consider funding sources for a K-9 unit. There is a substantial amount of training time and costs associated with this endeavor.
- #4 Members of the Fort Bragg Police Department are exposed to a variety of traumatic instances in the course and scope of their duties. Each event is reviewed on a case by case instance. Critical incidents that involve serious trauma, injury or threat would call for employees of the Fort Bragg Police Department to receive mandatory counseling services. In addition, counseling resources are made available by the City of Fort Bragg for all employees.
- This recommendation calls for actions involving other agencies. While the department can support this recommendation submitted by the Grand Jury; forensic and bookings programs are provided by federal, state and county agencies.

#6 The Fort Bragg Police Department is transitioning contracted dispatch services with Mendocino County Sheriff's Office to the Ukiah Police Department. The transition should occur by September 2009. The new service contract with Ukiah Police Department will provide access to a Mobile Computer System. The Fort Bragg Police Department has identified funding for the in car computers. The Fort Bragg Police Department will continue to research the feasibility of in car cameras.
