A Report on the Mendocino County Sheriff's Fort Bragg Substation

The Grand Jury requires me to respond to All Findings and Recommendations.

1. The Fort Bragg Substation is staffed by one lieutenant, one secretary who doubles as the evidence room tech, two sergeants and eight deputies (one is a trainee). The patrol area for the Fort Bragg office is the Navarro River Bridge to the north county line. The substation is also responsible for the south coast area which runs from the Navarro River Bridge to the south county line. South coast is staffed by one resident sergeant and one deputy.

Sheriffs Response:

I agree with findings.

2. There is a large screen telecommunications system where an early morning briefing is held each day with connections between the Sheriff's office in Ukiah and the Willits Substation.

Sheriffs Response:

I agree with findings.

3. There are two holding cells at the Fort Bragg Substation. The inmate(s) are observed every 15 minutes.

Sheriffs Response:

I agree with findings.

4. The policy of the Sheriff's office is to hold inmates for no longer than two hours and then transport them to Ukiah.

Sheriffs Response:

I agree with findings.

5. A deputy from the Fort Bragg Substation transports prisoners as far as the Willits Substation where they are picked up by an inland deputy to complete the trip to Ukiah.

Sheriffs Response:

Occasionally a Fort Bragg Deputy may transport the inmate to Ukiah. This decision would be based on staffing and possible medical needs of the inmate.

6. Prisoners are brought from Ukiah for court in Fort Bragg and are kept in the substation's holding cells.

Sheriffs Response:

I agree with findings.

7. There is one bilingual officer who receives additional pay for his language skills.

Sheriffs Response:

I agree with findings.

8. All deputies are POST certified (Peace Officer Standards and Training). They attend a POST academy for six months training. The local academies are located in Santa Rosa, Chico and Eureka. The training is normally paid for by the individual but the department can sponsor someone as well. The cost of training is approximately \$6,000.

Sheriffs Response:

I agree with findings.

9. All of the officers carry tasers. Two were trained at a "Train the Trainer" taser school and then trained the others.

Sheriffs Response:

Deputies are allowed to carry tasers if they choose after they have completed the mandated training.

10. Tasers are worn on the opposite side from the handgun to prevent accidental shootings.

Sheriffs Response:

11. New **deputies** are on probation for one year.

Sheriffs Response:

This is routinely the case.

12. The Sub-Station currently has no K-9 unit for **deputy** protection and drug "sniffing." It had one in the past and officers would like to reinstate it.

Sheriffs Response:

If the budgetary situation improves, deputies will be allowed to apply for the position of K-9 handler.

13. Only the south coast officers take their cars home when off duty.

Sheriffs Response:

The South Coast Deputies as well as deputies that are on-call routinely take their cars home.

14. Each patrol car at the Fort Bragg Substation is shared by two officers who are responsible for keeping it washed and clean.

Sheriffs Response:

I agree with findings.

15. The patrol cars have cameras but no computers. The camera data are downloaded to disc at the end of the shift.

Sheriffs Response:

I agree with findings.

16. There is a ride-along policy allowing civilians to ride with patrol officers.

Sheriffs Response:

I agree with findings.

17. The State Corrections Standards Authority visits the substation, without notice, on a biennial basis. Other inspections of the substation are done by the Fire Marshall and OSHA.

Sheriffs Response:

Other inspections are also handled by Public Health and Environmental Health, but not OSHA.

18. The County Sheriff's Office in Ukiah handles all dispatch.

Sheriffs Response:

As of July 1, 2009, the Sheriff's Office handles all dispatch responsibilities for Sheriff's Office personnel only. Ukiah Police Department handles Fort Bragg Police Department Dispatch responsibilities.

19. The deputies on the north coast work ten hour shifts with no overlap. There is no coverage for a four-hour period. The south coast coverage varies; however, there is always someone on call.

Sheriffs Response:

I agree with findings.

20. The evidence room has no computerized system for tracking evidence. A card system is still in use. For approximately 17 years the substation has requested a bar coding system. The Grand Jury noticed an abundance of backlogged material evidence awaiting clearance and proper disposal.

Sheriffs Response:

I agree with findings.

21. Confiscated firearms are destroyed in an Oakland foundry. Drugs and other hazardous materials are taken to a multi-agency purging area in San Francisco.

Sheriffs Response:

I agree with findings.

RECOMMENDATIONS:

The Grand Jury recommends that the Mendocino County Sheriff's Office:

1. Seek funding for a canine unit for the Fort Bragg Substation. (Finding 12)

Sheriffs Response:

USE	OF	FORCE	
-----	----	-------	--

PURPOSE:

This general order establishes the general policy on use of force by members of this office.

POLICY:

Any use of force by members of this office must be objectively reasonable in light of the facts and circumstances confronting the member. Whenever feasible, the member should give a warning prior to using force.

PROCEDURES:

I. SITUATIONAL ASSESSMENT:

- A. Situations requiring the use of force may happen suddenly. These situations are often tense, uncertain and rapidly changing. The reasonableness of a particular use of force is not capable of precise definition or mechanical application.
- B. General factors affecting the use of force decision include:
 - The nature and severity of the crime.
 - Whether the suspect is actively resisting.
 - Whether the suspect is attempting to escape custody.
 - 4. Whether the suspect poses an apparent threat to the member or others.
- C. Individual characteristics affecting the use of force decision include:
 - 1. Age
 - 2. Size
 - 3. Skill level
 - 4. Multiple subjects or multiple officers
 - 5. Relative strength

- D. Special circumstances affecting the use of force decision include:
 - 1. Proximity of a weapon
 - 2. Injury or exhaustion
 - 3. Influence of alcohol or drugs
 - 4. Mental status
 - 5. Environmental conditions
 - 6. Being in a position of tactical advantage or disadvantage
 - 7. Distance from the subject
 - 8. Threat to others
 - 9. Special knowledge about subject
 - 10. Availability of options

II. USE OF FORCE OPTIONS:

- A. The following list of options is in order of increasing force. This is a general list. It is not meant to be an exhaustive list of all techniques, nor is it meant to prohibit the use of a technique that is not listed.
 - 1. Verbal or physical directions or command
 - 2. Control holds
 - a. Escort position
 - b. Balance displacement
 - c. Grips
 - d. Joint manipulation
 - e. Nerve stimulation
 - 3. Mechanical restraint devices
 - a. Handcuffs
 - b. Leg restraints
 - 4. Take-down maneuvers
 - 5. Aerosol agents (OC, CS, CN)
 - 6. Electrical devices
 - a. Stun gun
 - b. Taser®
 - c. REACT® belt
 - 7. Empty-hand striking or kicking
 - 8. Impact weapons
 - 9. Pepperball®
 - 10. Lateral vascular neck restraint
 - 11. Less-lethal projectiles
 - 12. Deadly force
 - a. Firearms (other than less-lethal projectile launchers)
 - b. Such other force which, by its nature, is inherently likely to cause death.
- B. Members are not required to progress through each level of the force options when it is

clear, based on the circumstances, that lower-level techniques will not overcome the subject's resistance.

- C. Members shall not utilize any defensive weapons of the types listed above unless:
 - 1. They are authorized to carry and use the weapon; and
 - They have successfully completed a course of instruction approved by this office in the proper use of the weapons.

III. REPORTING AND DOCUMENTATION:

- A. All circumstances surrounding a use of force shall be documented in the narrative portion of the appropriate report. Information must minimally include:
 - 1. Circumstances leading to use of force
 - 2. Warnings issued
 - 3. Type of force used
 - 4. Effect of force
 - 5. Injuries sustained
 - 6. Treatment provided
 - 7. Photographic or other documentary evidence collected
- B. Any use of force defined in Section II., A.,5. through 12. above shall be immediately reported to the member's supervisor.
- C. All visible injuries resulting from a member's use of force must be photographed prior to or during the booking process.

IV. MEDICAL ATTENTION

- A. Any subject suffering a physical injury as a result of a member's use of force shall undergo a medical clearance prior to booking.
- B. When it is clear that a subject will require medical attention, the subject should be transported by ambulance.

FORT BRAGG SUBSTATION AND HOLDING CELLS A Report on the Mendocino County Sheriff's Fort Bragg Substation

May 13, 2009

Summary

The Grand Jury visited the Mendocino County Sheriff's Substation in Fort Bragg and found it to be well-staffed and well-managed. Despite repeated requests for an efficient bar coding system, the evidence room staff must still document and track evidence manually. This contributes to an abundance of backlogged material evidence awaiting clearance and proper disposal.

Background

California Penal Code states ... The Grand Jury shall inquire into the condition and management of the public prisons within the county [§ 919(b)] and ... The Grand Jury shall investigate and report on the operations, accounts and records of the officers, departments or functions of the county [§ 925]. On February 19, 2009, the Grand Jury undertook this charge by touring the Fort Bragg Substation, including the holding cells and evidence room.

By late August (approximately), the City of Fort Bragg dispatch services will be handled by the Ukiah Police Department. The Ukiah Police Department is still in the process of implementing communications software and hardware, and the Sheriff will continue to provide services until a formal request to discontinue services is received.

Required Response: Mendocino County Sheriff

As of July 1, 2009, the Sheriff's Office handles all dispatch responsibilities for Sheriff's Office personnel only. Ukiah Police Department handles Fort Bragg Police Department Dispatch responsibilities.

19. The deputies on the north coast work ten hour shifts with no overlap. There is no coverage for a four-hour period. The south coast coverage varies; however, there is always someone on call.
