CCP members agree to eliminate Ford Street Detox Program in lieu of jail; Ford Street Sober Living Environment (Probation & Public Defender) pro-rated amounts; SUDT Counselor at the jail; Sheriff's Deputy Liaison to Probation; Parole Holds reduced to \$60,000; Ankle Monitoring tabled; and eliminate the Contingency fund.

Further discussion held.

**Dave Eyster, District Attorney makes motion to stop cuts here, go on hold and see what comes out of the carryover and State monies to us and discuss further at future meeting.**

**All in favor. No nays. No abstentions. Motion passes.**
