The last day to file an appeal of the Zoning Administrator's decision is the 10th day after the hearing. To file an appeal, a written statement must be filed with the Clerk of the Board with a filing fee prior to the expiration of the above noted appeal period. If you challenge the project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this

notice, or in written correspondence delivered to the Department of Planning and Building Services at, or prior to, the public hearing. All persons are invited to appear and present testimony in this matter.

MEMORANDUM

May 28, 2021

RE: RN 2020-0012 Redtail Road and Peregrine Road

Redtail and *Peregrine Roads* are two private roads in the Boonville area that collectively serve approximately 15 parcels. *Redtail Road* is located 4.25± miles northwest of Boonville on the west side of Peachland Road (CR 128) 4± miles north of its intersection with State Route 128 (SR 128). *Peregrine Road* takes access from *Redtail Road*, 0.7± miles west of its intersection with Peachland Road (CR 128).

This road name request is the result of a conversation between the Planning and Building Services Department, the Anderson Valley Community Services District and the local property owners. At the request of the District, the Department began research into correcting some long outstanding addressing issues at the north end of Peachland Road. Outreach to the property owners spurred a larger discussion about adopting new road names, and these two names were proposed by the property owners and accepted by the Department and the District.

The project is consistent with the applicable goals and policies of the General Plan, the Mendocino County Addressing Ordinance (MCC Chapter 18.16) and has been determined to be Categorically Exempt from CEQA under Class 1(g). Therefore, staff recommends the Zoning Administrator adopt the names *Redtail Road* and *Peregrine Road* for these private roads, and finding the project to be Categorically Exempt, directs staff to assign addresses accordingly.

RESOLUTION OF THE ZONING ADMINISTRATOR, COUNTY OF MENDOCINO, STATE OF CALIFORNIA, ADOPTING A PRIVATE ROAD NAME

WHEREAS, the applicant, the County of Mendocino, has submitted a request to the Mendocino County Zoning Administrator to adopt the names *Redtail Road* and *Peregrine Road* for two private roads in the Boonville area, 4.25± miles northwest of Boonville on the west side of Peachland Road (CR 128) 4± miles north of its intersection with State Route 128 (SR 128); General Plan FL 160/RL 160; Zoning TPZ/RL; Supervisorial District 5; (the "Project"); and

WHEREAS, the Secretary for Resources has found that certain classes of projects have been determined not to have a significant effect on the environment and are therefore exempt from the requirement for the preparation of environmental documents, and the Project was determined to meet the criteria for a CATEGORICAL EXEMPTION from the California Environmental Quality Act (CEQA) under Class 1; and

WHEREAS, in accordance with applicable provisions of law, the Zoning Administrator held a public hearing on, June 10, 2021, at which time the Zoning Administrator heard and received all relevant testimony and evidence presented orally or in writing regarding the Project. All interested persons were given an opportunity to hear and be heard regarding the Project; and

WHEREAS, the Zoning Administrator has had an opportunity to review this Resolution and finds that it accurately sets forth the intentions of the Zoning Administrator regarding the Project.

NOW, THEREFORE, BE IT RESOLVED, that the Zoning Administrator makes the following findings;

- 1. **General Plan Consistency:** The project is consistent with applicable goals and policies of the General Plan; and
- 2. **Mendocino County Code Consistency:** The project is consistent with the County's Addressing Ordinance, MCC Chapter 18.16 with regard to private road names; and
- 3. Environmental Protection Findings: The proposed project has been determined to be Categorically Exempt from a CEQA Initial Study under a Class 1(g), Section 15301 exemption.

BE IT FURTHER RESOLVED that the Zoning Administrator hereby grants the requested Private Road Name, as identified and described in Exhibit "A", attached hereto.

BE IT FURTHER RESOLVED that the Zoning Administrator designates the Secretary as the custodian of the document and other material which constitutes the record of proceedings upon which the decision herein is based. These documents may be found at the office of the County of Mendocino Planning and Building Services, 860 North Bush Street, Ukiah, CA 95482.

BE IT FURTHER RESOLVED that the Zoning Administrator action shall be final on the 11th day after the date of the Resolution unless an appeal is taken.
