This document provides response pursuant to California Penal Code Section 933.05. to the Grand Jury findings and recommendations noted in their report dated November 3, 2005.

Findings:

Finding #1.

"The FBPD web-site is up and operational at the time

of inspection and continues to be expanded and

developed."

Response:

Agree.

Finding #2.

"The FBPD is staffed in accordance with its budget: one Chief, one Lieutenant, four Sergeants, ten Patrol officers two Community Service Officers (CSO) (one position is vacant), six Cadets, two Police Service Technicians (one is an Evidence Room Technician),

and an Executive Secretary."

Response:

Agree.

Finding #3.

"The FBPD staffing is affected by the number of

officers on temporary disability."

Response:

Disagree in part.

The officers on disability leave at the time of the Grand Jury visit have either returned to work or have retired. We have hired an officer to replace the retired officer.

Finding #4.

"Officer retention rates within rural communities such as Fort Bragg are affected by family circumstances and needs."

Response:

Agree.

Finding #5.

"Dispatching for the FBPD is performed through a contract with the Sheriff's Office."

Response:

Agree.

Finding #6.

"A high level of cooperation exists between the commanders of the FBPD and the Mendocino County Sheriff's Cast Sector Sub-Station."

Response:

Agree.

Finding #7.

"Additional safeguards for the disposal of evidence are to be implemented."

Response:

Agree.

Finding #8.

"Injury claims on the part of patrol officers have been reduced by 30% with the introduction and appropriate use of Tasers."

Agree.

Finding #9.

'The FBPD holding cell is physically located in the Mendocino County Sheriff's Coast Sector Sub-Station."

Agree.

Finding #10.

"The Fort Bragg Holding Cell lacks an audio monitoring system, resulting in non-compliance with California Code of Regulations 6031."

Response:

Agree in part.

Since the visit by the Grand Jury the County of Mendocino has installed an audio system in the cell

used by FBPD. The monitoring station is located in the Sheriff's Office. Consideration should be given to providing FBPD with a monitoring station also.

Finding #11.

"Transportation of prisoners to Ukiah or another facility is generally carried out within two hours."

Response:

Agree.

Finding #12.

The FBPD estimates that 75% to 80% of arrests are drug related (Methamphetamine or other drugs)."

Response:

Agree.

Recommendations:

Recommendation #1.

"The Grand Jury recommends that the Mendocino County of Buildings and Grounds install an audio monitoring system in the FBPD Holding Cell that is compliance with California Code of Regulation 6031. (Finding 10)"

Response:

The recommendation has been implemented. However a monitoring station should be provided to FBPD. Currently the only such station is located within the Sheriff's Office and FBPD officers cannot hear it.
