# 3a) Approval of Steps 2-4 Notes of the Action Steps Tracking

In reference to Part 4 (WIC 1995(3)(a)), Sheryn Hildebrand inquires about if we cannot facilitate a program or if we get too many kids and also inquires about an MOU with Sonoma County. Katie Ford states there is not a current MOU but there has been discussions. Further discussion held. Katie further states she believes we will be proactive once other counties have been identified who will have those certain programs, what the consortium will look like, and what contracts are created with other counties. There are a lot of unknowns from other counties on what they will and will not provide. Once these counties have been identified we are going to need to have an MOU in place in case it is ordered.

# 4. <u>Legislative Update</u>

### 4a) Receive update on Pre-Litigation Demand

Katie Ford presents update. For clarification this is a litigation demand made to the state on behalf of a youth advocate group. The pre-litigation demand letter states they want a method in place ensuring that all county sub-committees were correctly formed pursuant to the legislation before receiving any funds. Katie reported we are in compliance and other than naming this sub-committee as Brown Act, there are no issues. Requirements have been met.



# 5. Chief Probation Officers of California (CPOC) Update

**Receive update on SB 823 County Collaboration Consortium Workgroup**Katie Ford presents update. There was a document added into the agenda regarding the principals of what the goal of the Consortium workgroup is. Katie states the status of the workgroup is still ongoing and there is not any definite information that would be helpful with our planning at this point.

# 6. <u>Host Counties Secure Track Bed Rate Update</u>

# 6a) Receive update on Sonoma County Secure Track Bed Rate

Katie Ford presents update. Katie states the Secure Track Bed Rate for Sonoma County for a youth would be \$300 a day and come out to \$109,500 per year/per youth. That gives us an idea now in terms of our planning in what we can do with dollars. We received our confirmation letter last week that we are in fact going to receive \$250,000.00 for the first year. If we chose not to become a secure track county and were going to 100 percent contract out for housing our youth, with that first year money, we would only be able to house two youth with a little bit left over. It gives us an idea of what the cost point amounts are each year, as our funding increases and how many youth we can essentially house in our facility without needing additional general fund dollars. The increase for the second year is approximately \$460,000.00. Discussion held.
