- 1. Does the Water System Report satisfy Planning Needs for a Proof of Water (POW) report or analysis for any POW report?
- 2. The specific project is to develop a vacant parcel with a single-family residence (SFR), the first SFR, not a ADU. I understand that POW is not required by EH for the initial SFR. Yet I am really trying to understand how one will report a POW to Planning and how Planning can determine that the POW or Water system report submitted is sufficient per the Mendocino County Coastal Groundwater Development Guidelines (MCCGWDG).
