Hi Ms Krog-

I am writing to express concern about and opposition to the proposed project application AP 2021-0010 on Ray's Road, Philo.

I am a resident on Ray's Road, nearby the project. The neighborhood on Ray's Road is rural and quiet. There are several small properties surrounding the proposed site for the event which would be negatively impacted. We live there because of the peacefulness of the area.

The proposed project will bring excessive traffic which is not manageable on our small rural road. I don't know the exact number of residents on Ray's Road, but we are a very small fraction of the proposed 99-500 people for these events. There is already significant fire risk in the area, and if we had a fire, evacuating several hundred people would not be possible.

The project acknowledges that there will be amplified sound that likely will exceed the sound level set by the county. We do not want any loud acoustic noise. And we certainly don't want amplified noise 20 times a year. That would amount to every other weekend!

There are fair grounds in Boonville. Large events have and should take place there. Please be respectful of the residents of Ray's Road, and deny the application.
