#### 4. **Community Corrections Partnership (CCP) and Member Matters**

##### 4a) **Receive Update and Discuss as Needed the Status of the Relocation of GEO Day Reporting Center from Chief Probation Officer Izen Locatelli and GEO Reentry Staff and Give Direction to Staff as Needed**

Izen Locatelli, Probation, gave a summation of the lengthy search for a suitable location for the DRC. On May 19, 2022, prior to finalizing lease negotiations, a fire destroyed the proposed location at 1101 South Dora Street, Ukiah. Last week he viewed a potential site at 102 Scott Street, Ukiah. It is currently leased to the Hospital, but unoccupied. The lease will expire in January and the property owner would like a long-term lease.

It is recommended that GEO Reentry will handle lease negotiations with the property owner. Nick Canaday, GEO, indicates they have been in contact with a realtor. Matthew Kendall, MCSO, clarifies that CCP and the County will not be involved in lease negotiations, and will the space be shared with HHSA, as intended before? Izen Locatelli, Probation, confirms that only GEO will participate in lease negotiations and the space will not be shared. It is not big enough, and the anticipated costs will be within CCP's budget and does not necessitate sharing. Discussion held.
