**4. Community Corrections Partnership (CCP) and Member Matters**

**4a) Receive Update and Discuss as Needed the Status of Relocation of GEO Day Reporting Center from Chief Probation Officer Izen Locatelli and GEO Reentry Staff and Give Direction to Staff as Needed**

Report out by Izen Locatelli, Probation. Some language changes to lease needed per County Counsel's request. Possibly occupy the space by October. Discussion held.

**4b) Receive Update and Discuss as Needed the Status of the Mendocino County Pretrial Program from Chief Probation Officer Izen Locatelli and the Status of a Dedicated Modular Building at the Jail for the Pretrial Program**

Report out by Izen Locatelli, Probation. The Pretrial Program needs to be live by June 30, 2022. New staff is on board and training needs to happen. Funding being worked on for possibly having a modular at the Jail site. Discussion held.

**4c) Receive Fiscal Update on AB109 Funding for FY2021-22 and FY2022-23 Budget Including Growth Fund Projections**

Report out by Cathy White, Probation. The Governor's May revise was issued on May 13, 2022, which could increase the FY22-23 Base Funds and Growth Funds. Reminds everyone it is prudent to wait for final budget approval and for the Performance Criteria Calculations to be completed. Discussion held.



- 4d) Receive Annual Report from GEO Reentry Staff Regarding Reentry Day Reporting Center Services Provided with CCP Funding, Including Annual Recidivism Calculation, and Discuss as Needed**  
Report out by Amanda Lightfoote, GEO Reentry. There was a high level of participation despite the pandemic. Next month marks their 10-year anniversary. Once they are in their new location, they plan on celebrating the milestone. Clarification on how recidivism rates are tracked. Discussion held. Kim Turner, Courts, would like to commend GEO for their detailed reporting of data and statistics. They would like to see these reports made more easily accessible to the public.
- 4e) Receive Annual Report from Behavioral Health & Recovery Services (BHRS) Staff Regarding Mental Health and Substance Use Disorder Treatment (SUDT) Services Provided with CCP Funding and Discuss as Needed.**  
Report out by Jenine Miller, BHRS, Navin Bhandari, BHRS, and Jill Ales, SUDT. New curriculum was purchased this year with grant funds. Clarification on how services are requested while in custody. Discussion held. Jill Ales announces they will be hosting a Fentanyl training on June 24, 2022.
