Izen Locatelli, Probation, states this action is authorized by CCP.

Kim Turner, Courts, motions to approve the reallocation of the Public Defender's CCP approved budget for FY2021-22 decreasing the Legal Secretary line item by \$7,094.25 and increasing the Public Defender line item by \$7,094.25; authorize a supplemental 4<sup>th</sup> quarter claim in the amount of \$7,094.25 for Public Defender costs. Cedric Crook, UPD, seconds the motion. Vote taken. Motion passes.



# 4. <u>Community Corrections Partnership (CCP) and Member Matters</u>

4a) Receive Update and Discuss as Needed the Status of Relocation of GEO Day Reporting Center from Chief Probation Officer Izen Locatelli and GEO Reentry Staff and Give Direction to Staff as Needed

Izen Locatelli, Probation, reports out. The estimated monthly costs, including utilities and triple net costs, is \$5,489.00 for the first year. Nick Canaday, GEO, states they are still working on estimates from the contractor. It seems it is not as straightforward as initially thought. There are permits needed to move walls, some doorways are too narrow, air returns and lighting may need to be moved. The work could be subject to prevailing wages. He is hesitant to give a figure at this time, but could be as much as double the original estimate. Izen states things can be reassessed if needed but may have to weigh needs vs. wants. The most important thing is to get the program up and running. Nick Canaday agrees, operational wise, they could move in as is. Discussion held.

4b) Receive Update on the GEO Reentry Day Reporting Center from GEO Reentry Staff and Discuss as Needed

Nick Canaday, GEO, states he is working on the semi-annual report and should have it ready for the November meeting.

4c) Receive Update and Discuss as Needed the Status of the Mendocino County Pretrial Program from Chief Probation Officer Izen Locatelli and the Status of a Dedicated Modular Building at the Jail for the Pretrial Program Izen Locatelli, Probation, reports out. He states there is a Pretrial workshop on September 1<sup>st</sup> and will have more information to report after. Izen states the modular costs per the County Facilities Department could be \$400,000 to \$600,000. Kim Turner, Courts, asks what is in the modular and what are the costs for? Izen states there is no plumbing, just workspace, power, and fiber. Joyce Spears, MCSO, states the location for the modular is good, however water and power lines will need to be moved and that is where some of the cost is coming from.

Kim Turner, Courts, motions to approve designation of Mendocino County Administration Center, Conference Room C, 501 Low Gap Road, Ukiah CA 95482 as the primary meeting location for CCP Meetings, and designate the Mendocino County Superior Court, Dept. G, as the contingent location.

Jeffrey Aaron, Public Defender, seconds the motion. Vote taken. Motion passes.
