¹ For two consecutive weeks, the Superior Court did not check-in a pool of potential jurors sufficient to complete jury selection and empanel a sworn jury to hear the evidence. As a result, a mistrial was declared and the defendant's trial was continued to late July. During the effort to complete jury selection in late July, the defendant decided he didn't want a jury trial and, instead, pled guilty to second degree murder by use of a bladed instrument. Because the issues in this case never got to a jury, it is neither weighed as a trial win or a trial loss.

² A Mendocino County jury returned from its deliberations and announced it was unable to reach unanimous verdicts as to the charges pending against the two co-defendants. Following a review by the DA and his senior attorneys, the prosecution's motion to sever the two co-defendants from a single trial into two separate trials. Defendant Williams was found guilty as charged by a later jury on July 20, 2022. Defendant Frank's case was dismissed in light of the co-defendant's greater role and conviction.

³ A Mendocino County jury returned from its deliberations Wednesday, May 25th, to announce it was unable to reach unanimous verdicts as to the charges pending against the trial defendant. The hung jury split was disclosed as 11 for guilty to 1. The matter was continued to the following day for the parties to decide what to do next. On Thursday, defendant Dickerson withdrew his not guilty plea and entered a no contest plea to a misdemeanor violation of Vehicle Code section 23152(a), driving a motor vehicle under the influence of alcohol. Accordingly, the resolution of this trial case is weighted as a win for purposes of statistics.

⁴ A Mendocino County jury returned from its deliberations on July 5, 2022 to announce it was unable to reach unanimous verdicts as to all charges pending against the trial defendant. Following a review by the DA and his senior attorneys and status conferences, a retrial before a different jury has now been calendared to begin jury selection on March 6, 2023 in the Ukiah courthouse (Department H).

⁵ A Mendocino County jury returned from its deliberations on December 7, 2022 to announce it was unable to reach an unanimous verdict in a unique criminal/civil trial relating to the involuntary psychiatric commitment and treatment of a convicted felon who the mental health professionals have opined has a severe mental disorder, that the severe mental disorder is not in remission or cannot be kept in remission if the person's treatment is not continued, and that, by reason of his severe mental disorder, the felon represents a substantial danger of physical harm to others. The trial was on the issue of whether the involuntary treatment should or should not be continued. Given the split of the jurors favoring the prosecution's position for continued treatment, it is highly likely that the District Attorney will authorize a retrial in front of a new jury.
