The Zoning Administrator's action regarding this item shall be final unless appealed to the Board of Supervisors. The last day to file an appeal of the Zoning Administrator's decision is the 10th day after the hearing. To file an appeal, a written statement must be filed with the Clerk of the Board with a filing fee prior to the expiration of the above noted appeal period. If you challenge the project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Department of Planning and Building Services at, or prior to, the public hearing. All persons are invited to appear and present testimony in this matter.

SUBJECT: Private Road Name Request RN 2022-0004 (Lincoln Ridge Road)

On October 3rd, 2022, the Planning and Building Services Department received outreach from CALFIRE concerning the duplicative road name *Seaview Drive* in the Westport Area. *Seaview Drive* is currently the name of a private road 2.6± miles north of Westport serving approximately 17 parcels, as well as a County Road (CR 428-C) within the village of Westport serving approximately 10 parcels. This situation has repeatedly resulted in significant delays for emergency services when responding to 911 calls on “Seaview Drive”

To remedy this, staff is recommending the private *Seaview Drive* be renamed to *Lincoln Ridge Road*, to reflect its location along the top of Lincoln Ridge as designated on the USGS Topo maps. Project referrals and requests for comment were sent out on October 5, 2022. Approval was recommended by both CALFIRE and the Mendocino County Sheriff’s Office, among others. No response was received by any of the property owners.

The project is consistent with the applicable goals and policies of the General Plan, the Mendocino County Addressing Ordinance (MCC Section 18.16) and has been determined to be Categorically Exempt from CEQA under Class 1(g) {Existing Facilities; New copy on existing on and off-premises signs}. Therefore, staff recommends the Zoning Administrator approve the name *Lincoln Ridge Road* in place of the existing *Seaview Drive*, and finding the project to be Categorically Exempt, direct staff to assign addresses accordingly.






LOCATION MAP

RESOLUTION OF THE ZONING ADMINISTRATOR, COUNTY OF MENDOCINO, STATE OF CALIFORNIA ADOPTING THE NAME 'LINCOLN RIDGE ROAD' FOR A PRIVATE ROAD IN THE WESTPORT AREA.

WHEREAS, the applicant, the COUNTY OF MENDOCINO, filed a request to change the name of an existing private road located 2.6± miles north of Westport on the east side of State Route 1 (SR 1) opposite Westport Union Landing State Beach; General Plan Classification: Remote Residential (RMR); Zoning: Remote Residential (RMR) and Upland Residential (UR); Supervisorial District 4; (the "Project"); and

WHEREAS, the Secretary for Resources has found that certain classes of projects have been determined not to have a significant effect on the environment and are therefore exempt from the requirement for the preparation of environmental documents, and the Project was determined to meet the criteria for a CATEGORICAL EXEMPTION from the California Environmental Quality Act (CEQA) under Class 1g; and

WHEREAS, in accordance with applicable provisions of law, the Zoning Administrator held a public hearing on February 9, 2023 at which time the Zoning Administrator heard and received all relevant testimony and evidence presented orally or in writing regarding the Project. All interested persons were given an opportunity to hear and be heard regarding the Project; and

WHEREAS, the Zoning Administrator has had an opportunity to review this Resolution and finds that it accurately sets forth the intentions of the Zoning Administrator regarding the Project.

NOW, THEREFORE, BE IT RESOLVED, that the Zoning Administrator makes the following findings;

1. **General Plan Consistency:** The project is consistent with applicable goals and policies of the General Plan; and
2. **Mendocino County Code Consistency:** The project is consistent with the County's Addressing Ordinance, MCC Section 18.16 with regard to private road names; and
3. **Environmental Protection Findings:** The proposed project has been determined to be Categorically Exempt from a CEQA Initial Study under a Class 1(g), Section 15301 exemption.

BE IT FURTHER RESOLVED that the Zoning Administrator hereby grants the requested Private Road Name, as identified and described in Exhibit "A", attached hereto.




