This project is currently scheduled for review by the Zoning Administrator Thursday, January 12<sup>TH</sup> 2023. Staff's current recommendation is to adopt the name *Westport Way* for this currently unnamed frontage road. Another property owner has suggested the name *Shoreline Drive*, which would also be acceptable. The ZA also has the option to reject the proposal entirely and leave the road unnamed, but given the recent prioritization of emergency services and specifically fire response, that option seems less likely.
