#### Recommended Action:

Approve submission of request by the CCP to the Mendocino County Board of Supervisors (BOS) to utilize Local Innovation Subaccount Funds to cover costs for the Pretrial Release Program's modular building to be located within the Jail Perimeter in excess of funds previously allocated to the project; instruct Probation Department to prepare consent agenda item for the February 28, 2023, BOS meeting, or as soon as is practicable, for presentation by the Chief Probation Officer.

4c) Discussion and Approval to Utilize Community Corrections Partnership Contingency Funds to Cover Costs for Pretrial Release Program's Modular Building to be Located Within the Jail Perimeter in Excess of Funds Previously Allocated to the Project Should the Mendocino County Board of Supervisors (BOS) Decline Use of Local Innovation Subaccount Funds for this Purpose and if Total Project Costs Exceed Available Local Innovation Subaccount Funds Approved by the BOS.

#### Recommended Action:

Approve the utilization of Community Corrections Partnership Contingency Funds to cover the costs for the Pretrial Release Program's modular building to be located within the Jail perimeter in excess of funds previously allocated to the project should the Mendocino County Board of Supervisors (BOS) decline use of Local Innovation Subaccount funds for this purpose and if total project costs exceed available Local Innovation Subaccount Funds approved by the BOS.

Discussion held. Juanita Dreiling, MCSO, states there may be some available project cost sharing funds of approximately \$150,000 which were turned back to the Executive Office due to canceled utilization. Cathy White, Probation, states that the Local Innovation Subaccount fund will have additional contributions in FY2023-24. Kim Turner, Courts, would like clarification of priorities for use of funds. Kim Turner, Courts, motions to approve the recommended action with an amendment of all available Local Innovations Subaccount funds to be used first, second the potential MCSO project cost sharing funds if available and last the CCP contingency funds. Matthew Kendall, MCSO, seconds the motion. Vote taken. Motion as amended passes unanimously.
