3a) Approval of Minutes of March 25, 2022, Regular Meeting

Ted Williams, BOS, moves to approve the JJCC minutes from March 25, 2022.

Matthew Kendall, MCSO seconds the motion. Jeffrey Aaron, PD, Cedric Crook, UPD, and Chandra Caffery, DA, all abstain from the vote. Remaining members vote. Motion passes.

4. Juvenile Justice Coordinating Council and Member Matters

4a) Review, discuss and approve the JJCPA-YOBG 2022 Expenditure and Data Report; Authorize the Chief Probation Officer to Submit the Approved Report to the BSCC by the October 1, 2022, Due Date; and Authorize the Chief Probation Officer to Present the Report to the Mendocino County Board of Supervisors

Ted Williams, BOS, moves to approve the JJCPA-YOBG 2022 Expenditure and Data Report; Authorize the Chief Probation Officer to Submit the Approved Report to BSCC by October 1,



2022; and Authorize the Chief Probation Officer to present the report to the Mendocino County Board of Supervisors. Jeffrey Aaron, PD, seconds the motion. Vote taken; motion passes unanimously.

4b) Receive Update and Discuss as Needed the Status of Juvenile Justice Realignment, Including but Not Limited to Juvenile Justice Realignment Block Grant (SB823) Implementation and Office of Youth and Community Restoration (OYCR), from Chief Probation Officer Izen Locatelli

Izen Locatelli, Probation requests Debra Lewis, OYCR, report on the newly formed office. Debra is working with her team to set a meeting with Mendocino County. A tentative date of November 30, 2022 is set. She invites everyone to a listening session next week, with project grants being a topic and input is appreciated. Information and the zoom link sent to all in attendance. Izen Locatelli, Probation, reports there is a contract with Sonoma County for placement, as there is only one youth.

Ted William, BOS, moves to receive the update. Jeffrey Aaron, PD, seconds the motion. Vote taken; motion passes unanimously.

4c) Receive and Discuss as Needed a Summary of the Juvenile Facility Grant (AB178) 2022 from Chief Probation Officer Izen Locatelli

Izen Locatelli, Probation, reports out. Jeffrey Aaron, PD, asks if the allocation will be used to create secure housing. Izen states there already is one, C Unit at the Juvenile Hall. Ted Williams, BOS, asks about data regarding treating youth locally vs. out of county. Izen explains the state has directed them to try to treat youth locally, but the economy and scale do not always work in this county. If there were 3-5 general population secure youth, it would be feasible to house them and staff the unit.

Ted Williams, BOS, moves to receive the update. Jeffrey Aaron, PD, seconds the motion. Vote taken; motion passes unanimously.

4d) JJCC Members report on items of general interest

Matthew Kendall, MCSO, would like to thank Noah Block for coming out to meet with Tribal Leaders with a presentation about local resources available.

Katie Ford, Probation, would like to remind everyone she will be sending out the Comprehensive Juvenile Justice Plan and would like everyone to review, as the next meeting will be finalizing the plan.

Sheryn Hildebrand, CASA, is pleased to announce they are developing an App for families and parents to access resources. There will be a key word search function, with the goal to make sure



there will be Spanish translation. Parents can remain anonymous, and there will be a chat feature, along with a crisis line. This is one of the first of its kind in the nation.

Jason Iversen, UUSD, is excited about this, it's an "outstanding idea".

4e) Review and discuss requests for items to be included on future agenda, including agenda date or dates, and give direction to staff as needed

Matthew Kendall, MCSO, moves to request things be kept "fluid" with the Holidays approaching, as there tends to be more issues. Jason Iversen, UUSD, seconds the motion. Vote taken; motion passes unanimously.
