4A.) DISCUSSION AND POSSIBLE DIRECTION TO STAFF REGARDING THE 1989 VS. THE 1994 DISTRICT LAWS.

Emily Brown from Civitas, discussed the difference between the two district laws and the benefits to potential conversion to the 1994 regulations.

The consensus of the Board was to pursue the conversion of the BID to the 1994 District laws beginning upon the adoption of the Annual Report by the Board of Supervisors.

4B.) DISCUSSION AND CONTINUED PREPARATION OF THE BID DRAFT ANNUAL REPORT FOR FY 23/24.

The Board continued to discuss the preparation of the BID Annual Report. Included in their recommendations were to pursue conversion of the BID from the 1989 to the 1994 District Laws as well as to reduce the requested match to the County of Mendocino in order to become self-reliant and not request as much County General Fund dollars in future budget cycles.
