# 1. Roll Call.

The meeting was called to order at 3:00 p.m. Roll call was established by the Clerk.

## 2. Regular Calendar.

#### 2a. CASE#: ALUC 4-2012

<u>DATE FILED:</u> 12/17/2012 <u>OWNER:</u> VARIOUS <u>APPLICANT:</u> CITY OF UKIAH

REQUEST: Airport Land Use Consistency determination of a proposed City of Ukiah Rezoning.

LOCATION: The vacant property located in the southern portion of the Ukiah City Limits, east of Airport Park Boulevard in the

Airport Business Park.

PROJECT COORDINATOR: FRED TARR

Mr. Fred Tarr, staff for the Airport Land Use Commission (ALUC), discussed the consistency review of a rezoning in the City of Ukiah for Costco. He noted the current zoning was for auto/commercial and the rezoning would change the site to commercial/retail. He discussed the State regulations that require the ALUC to take action on compatibility of rezoning and noted the developments in area. Mr. Tarr stated that staff felt the project was compatible with the Airport Comprehensive Land Use Plan (ACLUP) and the associated findings could be made.

Chair Simone asked Mr. Stump to proceed with his presentation.

Mr. Stump, City of Ukiah Planning & Community Development Director, discussed the zoning in the area noting it was Planned Development (PD) and each development would need to be consistent with ACLUP. He felt the project would be compatible with Zone C and did not feel the rezoning would affect anything.

Commissioner Crane discussed the open land calculation and how parking spaces were counted; whether there was a hypothetical conceptual plan for landscaping requirement.

Mr. Stump stated calculations were not completed for retail stores and parking was considered open space. He stated landscaping must equal 20%.

Commissioner Shelton discussed the Walmart expansion and traffic mitigation and asked how Costco would be accommodating the issue.

Mr. Stump noted the primary issue with Walmart was their inability to meet the landscaping requirements of 20%.

Commissioner Gawthrop asked if the design had been preapproved for Costco or another structure.

Mr. Stump stated his understanding was there would be one structure and filling station, but nothing was approved, the application was in process.

The public hearing was declared open, seeing no one come forward, the public hearing was declared closed.

Upon motion by Commissioner Holtkamp, seconded by Commissioner Shelton and carried by the following voice vote of (7-0), IT IS ORDERED that Airport Land Use Commission find that ALUC 4-2012, the proposed rezoning of the 15.33+/- acres located immediately west of Highway 101 on Airport Park Boulevard from Industrial/Auto Commercial to Commercial Retail, is consistent with the Mendocino County Airport Comprehensive Land Use Plan.
