REQUEST: Coastal Development Use Permit to authorize construction and operation of a wireless communication facility consisting of a 130 foot tall monopine (monopole designed to resemble a pine tree) with various appurtenant equipment and ground equipment including a 20KW generator with a 92 gallon storage tank and assorted equipment cabinets. Associated improvements include establishment of access to the site via a gravel and partially asphalt paved road and trenching of power and fiber to the site location. The proposed monopine will be located within a 1,800 square-foot fenced compound.
