Mr. Gonzalez discussed current recruitments and appointments with the Commission.

Mr. Oliphant discussed the new Cal Fire procedure regarding 4290 Regulations. He informed the Commission that the procedure was in draft form and still in development. Mr. Oliphant stated that the applicant would start with Planning and Building Services, then go to CalFire, and then bring their completed form to the Planning &

Building Department. Mr. Oliphant stated that there would be a two week turnaround for Cal Fire to complete their part of the plan check. He also discussed that the effective date would be in January 2022.

Noticed Public Hearing - Review and consider a recommendation to the Board of Supervisors on proposed adoption of amendments to the Mendocino County Local Coastal Program Land Use Plan (General Plan Coastal Element) and Implementation Program (Coastal Zoning Code) to regulate development of Accessory Dwelling Units in the Coastal Zone. Within the unincorporated areas of Mendocino County located inside the Coastal Zone boundary (Mendocino County Code, Title 20, Division II), excluding the Town of Mendocino (Mendocino County Code, Title 20, Division III).
