OWNER/APPLICANT: ANNA DENISE MOODY

REQUEST: Standard Coastal Development Permit, after the fact, to permit two (2) 120 square foot storage buildings, replace two (2) footings and sidings to a legal non-conforming 450 square foot outbuilding. The request includes removal of an unpermitted 64 square foot playhouse, hot tub, plumbing, electrical panel and line, a fence from inside the dunes and a greenhouse by the entrance.

LOCATION: In the Coastal Zone, 3.2± miles north of Cleone, on the west side of State Route 1

(SR 1), located at 27730 N. Hwy 1 (APN 069-010-13).

REQUEST: After-the-fact Major Vegetation Removal of 14 trees, SFD additions, construction of accessory structures, and removal of a water tower. Proposed gated wood fence, varying in height from 3.5 to 6 feet, and 4588 square feet of paved driveway. Removed trees will be partially

replaced by new Redwoods.

ENVIRONMENTAL DETERMINATION: Categorically Exempt

LOCATION: In the Coastal Zone, 3.2± miles south-southwest of the center of Fort Bragg, along the east side of Pacific Way (CR 436A) after it turns north 0.35± miles west of its intersection with Ocean Drive (CR 436), located at 33550 Pacific Way, Fort Bragg (APN 017-320-27).

APPEAL PROCESS. Persons who are dissatisfied with a decision of the Coastal Permit Administrator may appeal the action to the Board of Supervisors. An appeal must be made in writing along with the applicable fee to the Clerk of the Board within 10 days of the Coastal Permit Administrator's decision. The appeal issue will be placed on the next available Board of Supervisor's agenda for consideration, and the appellant will be notified of the time and date. Appeals to the Board of Supervisors do not necessarily guarantee that the Coastal Permit Administrator's decision will be overturned. In some cases, the Board of Supervisors may not have the legal authority to overturn the decision of the Administrator
