Matthew Kendall, MCSO, reports there have been no issues with public safety. There is a need to expedite the transfer of State Prison inmates and will work with the Courts if there is a backlog.

Izen Locatelli, Probation, would like Jacque Williams to report on an upcoming change at Ford St. Jacque states there is a need to repurpose the SLE beds to Withdraw Management, which would mean agreeing on an end date for the current contract between CCP and Ford St. Discussion held. Alternatives need to be explored and further discussion regarding end date will need to be had.
