- c) Karen Mattson reported that the County of Mendocino is experiencing extreme financial challenges and an ADHOC committee is seeking to maximize efficiency and restructure to ensure cost savings where possible. Neeka Aguirre proposed that the MAB write a letter calling for action on the future of the Museum. Rebecca Seconded the motion. All voted in favor of composing a letter and asked Brent Walker to mail it.
- d) Brent Walker reported that the Friends of the Museum now have merchandise for sale on Zazzle and shared examples of the products that can be purchased.

Museum Report

March 13, 2024 Museum Administrator, Karen Mattson

The Museum is busy as always!

- Behind-the-Scenes Tours are in full swing. The Museum is delighted to have an
 expanded team of volunteers leading tours and interpreting our collection. This spring
 our tour features collections pertaining to the *Frolic* shipwreck of 1850, famed local
 outlaw Black Bart, unique textiles, photographs, and the recently added MacNab's Men's
 Wear sign from Ukiah.
- Our current exhibit, In the Field: Exploring Botany in Mendocino County is a celebration
 of the study of unique plants that grow in our region. Building on past exhibit, Carl Purdy:
 A Passion for Plants, developed by Curator Dot Brovarney, In the Field reflects on the
 pursuits of Mendocino County botanists from past to present. The exhibit has been well
 received and staff is busy developing additional programs relating to this exhibit for the
 spring.
- The spring edition of the *Mud Wagon* Museum Newsletter has been published. It can be found here, it can also be accessed through our website and is delivered to all that elect to receive it. Reading our Newsletter is a great way to lean about past and upcoming programs and activities at the Museum.
- On February 6, the Board of Supervisors provided direction to staff to proceed with exploring the feasibility of implementing a new model of operation for the Mendocino County Museum; directed the Museum Ad Hoc Committee to work with community members on moving the Museum forward along the lines of the Kern County Museum Model with the intent to bring back a transition plan and Memorandum of Understanding to create a long term plan between the County of Mendocino, The City of Willits, and other partners. The County aims to gradually reduce reliance on the General Fund for revenue and is working to develop strategies to increase self-sufficiency. The Museum has planned a community meeting on March 13, to discuss the new model and has invited Executive Director Mike McCoy of Kern County to speak about his experience managing a museum under a non-profit/public partnership.
