Kim Turner, Courts, reports the plans for the new Courthouse are moving forward. The interior floor plans are almost finalized. It will be an 82,000 sq. ft. 3-story facility. If all goes well, groundbreaking will start February 2025.

Izen Locatelli, Probation, reports staffing levels in the Juvenile Hall are much better, while staffing in Probation is low, primarily with Field Officers.
