Ukiah Municipal Airport Land Use Compatibility Plan (UKIALUCP) Consistency Determination for requested modification of a previously-approved vesting tentative map and its associated development agreement. The approved project has a total of 171 residential parcels with attached and detached residences ranging from one- to three-stories in height. The revised project proposes 132 single-family residential parcels and 39 age-restricted senior housing parcels with all single-story residences. Parkland and open space would also be included on the approximately 48.8 acre site. 2± miles south of the City of Ukiah, lying on the west side of South State Street (CR104A), immediately south of its intersection with Gobalet Lane (Private) addressed at 3000 South State Street; APNs 184-110-28, 184-110-29, 184-120-21 & 184-120-01.
