





# Albion-Little River Fire Protection District



#### **Our Vision**

To provide the community, our firefighters and our first responders with a fully functional firehouse that is up to date with fully equipped modern fire trucks, adequate fire-fighting equipment and effective training programs.

# History

The Albion-Little River community 810 fire station, located near the Albion post office, was built over 60 years ago. The station is not large enough to house more than one rescue truck let alone a full-sized fire engine. It was built when the community and entire coast was much less populated. Although this building has served as a central fire station, it does not meet today's standards. Today's fire regulations and safety standards for both firefighters and residents deserve to be brought to current safety standards.

As the Albion-Little River communities have grown, so have the responsibilities and demands associated with protecting our lives, property and environment.

The fundamental building design goal is to create a cost effective, healthy, energy efficient building that will encompass hybrid solar and heat pump systems, along with air ventilation systems that will protect our firefighters with today's and future air quality standards. Planning for both energy efficiency and cost savings will benefit the community into the future.



## **New Fire Station**

The proposed fire station will have two separate buildings—an apparatus bay for housing fire trucks and equipment and serving as a training center. The second detached building shall be an administrative building that provides administrative offices, a large multi purpose room that will serve both the firefighters and the community for training, education and meetings, bathrooms, kitchen and dining area that can serve both fire-fighting personnel along with fundraising events. The upstairs provides training facilities and future sleeping quarters for our fire personnel.

The planning efforts continue to take into account the fact that climate change, increasing and changing community population (fewer volunteers and greater expectations) requires consistent staffing and reliable modern equipment.
