As promised, Staff is following up with this email regarding the discussion topics of todays phone call, which are:

- Per our phone discussion, you as the owner and applicant of CDP_2022-0034 (Johnson) are requesting your CDP_2022-0034 project be continued pending the approval of a test well CDP request. Staff recommends a request for continuance to a date certain of October24, 2024 to avoid additional Noticing Fees; and
 - a. **Provide a written response** to this email for the record of your request for continuance to a date certain of October24, 2024.
 - b. Staff will prepare a memorandum to the CPA at the April 25, 2024 CPA Hearing with your request to continue to a date certain of October 24, 2024; and
- You requested a copy of the Categorical Exclusion Order, E-91-2A. Staff was not able to locate a digital link to the Exclusion order, however, attached is a scanned copy for your reference. Please take note the Order does not apply to test well locations within 100 feet of any wetland or riparian area, such as your two (2) proposed well locations; and
- 3. A <u>CDP Application</u> for a test well is attached for your use; and
- 4. Staff has combined the attached pertinent and required documents form you current CDP_2024-0034 application that may be used as supplementary to your new CDP request for a Test Well; and
 - a. **Provide a written response** to this email that the attached combined PDF includes your proposed test well and supplemental documents is the correct packet for your forthcoming CDP Application.
