ADDENDUM NO. 1

The following changes will be made on the Contract as Addendum No. 1.
For informational purposes, the referenced Prevailing Wage Rates are also attached to this addendum.

BOOK 1 OF 2:

Insert the attached federal minimum wage rate determinations into the Notice to Bidders.

Replace the website in the Notice to Bidders, page NTB-2, with:

Replace the definition of "plant establishment period" in Section 1-1.07B of the Standard Specifications with:

Plant establishment period: time period after all planting work has been completed until Contract acceptance as determined by the engineer.

Add to section 19-1.03D:

There are Buried Man-Made objects within the channel from prior construction and previous bridges that crossed the creek in this location. Objects include concrete slabs, pile cap, and piles. Remove and dispose of Buried Man-Made objects within the channel that conflict with the channel grading and improvements.

Replace section 19-1.04 with:

Removal and disposal of Buried Man-Made objects within the limits of channel improvements is paid under Channel Excavation.

Delete from Section 20-4.01A:

"This project has a Type 2 plant establishment period."

Replace section 20-4.01B with:

"plant establishment: Plant establishment period starting after all planting work has been completed until Contract acceptance. The County will not accept the Contract unless the plant establishment work has been satisfactorily performed for at least the period specified for plant establishment."

Replace section 20-4.01C(1) with:

Reserved

Replace the table in section 60-2.01A with:

Bridge no./Structure name	Description of work
Br. No. 10C0065/Ackerman Creek Bridge	Entire bridge including abutments and bridge railing and abandoned waterline attached to the bridge
Fish ladder and weir located approximately 50 feet downstream (east) of the bridge.	Completely remove H-piles and timber lagging up to 2' below the elevation of engineered streambed material
Bridge foundations from prior structures	Remove concrete, piles, and other buried man-made objects that conflict with bridge and channel improvements

Add to section 70-7.04:

The 30” diameter casing embedded in the bridge diaphragms and 40” casing embedded in the abutment backwalls are part of Millview County Water District water line work and are included under Bid Additive 1. Payment for these casings is considered included in the Additive 1 bid item of Pipe (Station, Distribution, and Drainage).

BOOK 1 OF 2, APPENDIX B:

Replace the final sentence of section 1.02A with:

Submit prior project list within 5 days of bid opening. MCWD may use this information in awarding Bid Additive 1. The County will not use this information as the basis of qualification or disqualification for the Base Bid.

Replace the final paragraph of section 1.04A with:

Whenever reference is made to "CalTrans Standard Specifications" it shall be understood to be the most recent addition of the State of California, Department of Transportation Standard Specifications.

Whenever there is a conflict between the Project Special Provisions and the Millview County Water District Specifications and Condition, the following hierarchy shall apply:

1. In the event of a conflict between the Project Special Provisions and Division 1-3 of the Millview County Water District specifications, the Project's Special Provisions govern over Millview's specifications, except as authorized by the Engineer.
2. In the event of a conflict between the Project Special Provisions and Division 5 of the Millview County Water District specifications, Millview's specifications govern over the Project's Special Provisions, except as authorized by the Engineer.

Delete Items #1. - #3. Under part A of Section 1.07

Add to Part 4 of Section 15025 Pipe:

Payment for steel casings carrying water line pipe on the bridge is considered included in the payment of Bid Item No. 10 – PIPE (STATION, DISTRIBUTION, AND DRAINAGE).



Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year. The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate

changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7). Write to:

The request should be accompanied by a full statement of the interested party's position and by any information (wage payment data, project description, area practice material, etc.) that the requestor considers relevant to the issue.

3.) If the decision of the Administrator is not favorable, an interested party may appeal directly to the Administrative Review Board (formerly the Wage Appeals Board). Write to:

4.) All decisions by the Administrative Review Board are final.
