#### 2. Public Comment for items not on agenda

Chris Geiger from Center Point DAAC makes a brief presentation as a possible provider for a Recovery Residence located in Ukiah. The proposed facility would provide 6-12 SLE beds. Izen Locatelli, Probation, reminds the group that CCP cannot take action at this time, as it is not on the agenda, but the Executive Committee could vote to set aside funds for SLE beds in the Proposed Budget.

Kim Turner, Courts, motions to approve recommended action. Eric Rennert, Public Defender, seconds the motion. Vote taken. David Eyster, District Attorney, abstains. Motion passes.

#### 4. <u>Community Corrections Partnership (CCP) and Member Matters</u>

# 4a) Discussion and Development of a Proposed CCP Budget for Fiscal Year (FY) 2024-25

Recommended Action:

Approve the FY 2024-25 CCP proposed budget as recommended, direct the Probation Department to prepare the required documents for presentation of the proposed budget to the Mendocino County Board of Supervisors on April 23, 2024.

Izen Locatelli, Probation, will have each department present their request with a vote to be taken for each. Cathy White, Probation, goes over the Budget Comparison, Utilization, and Prior Year's History Reports. Brief discussion held.



<u>Ukiah Police Department</u> – Cedric Crook presents. Request remains the same as previous years, which he points out covers approximately 2/3 of an officer. UPD has been able to capture some data, as requested last year, and has implemented new procedures to capture more moving forward for a more complete report. Brief discussion held. Kim Turner, Courts, motions to approve as requested. Eric Rennert, Public Defender, seconds the motion. Vote taken. Motion passes unanimously.

<u>Public Defender</u> – Eric Rennert presents. Request is a 14.1% increase over last year. Questions posed regarding the increase and the justification. Request prepared by PD fiscal staff who was not present to clarify. Discussion held. David Eyster, District Attorney, motions to approve request in the same amount as FY 23/24. Kim Turner, Courts, seconds the motion. Vote taken. Eric Rennert, Public Defender, abstains. Motion passes.

<u>District Attorney</u> – David Eyster presents. This year's request is a 2.33% decrease from last year. Brief discussion held. Kim Turner, Courts, motions to approve as requested. Cedric Crook, UPD, seconds the motion. Vote taken. Motion passes unanimously.

<u>BHRS</u> – Karen Lovato presents. This year's request is a 2.2% decrease from last year, stating other funding sources can be used. Brief discussion held. Kim Turner, Court, motions to approve as requested. David Eyster seconds the motion. Vote taken. Motion passes unanimously.

<u>Probation</u> – Izen Locatelli presents. This year's request is a 0.12% increase over last year. Discussion held. David Eyster, District Attorney, motions to approve as requested. Eric Rennert, Public Defender, seconds the motion. Vote taken. Motion passes unanimously.

GEO – Mollyrose Graves and Nick Canaday present. This year's request is a 37.89% increase over last year. Questions posed regarding the increase. Izen Locatelli clarifies GEO had not increased rates in 10 years and a new contract is being negotiated with additional services. The new contract will include DRC services for the Willits office, which was previously funded by SB 678 funds. Due to state reduction of SB 678 funds by approximately 67% for FY2024-25, there are insufficient funds to continue coverage with SB 678 funds. New contract will also include funding for adult-in-custody services at the Jail. Discussion held. Kim Turner, Courts, motions to approve as requested. Matthew Kendall, MCSO, seconds the motion. Vote taken. Six votes in favor, one against. Motion passes.



<u>Sheriff's Office</u> – Matthew Kendall presents. This year's request is an 7.94% increase over last year. Sheriff clarifies escalating food and medical costs are a factor, as well as salary increases. Discussion held. David Eyster, District Attorney, motions to approve as requested. Cedric Crook, UPD, seconds the motion. Vote taken. Motion passes unanimously.

<u>SLE</u> – Izen Locatelli presents. In the past, Ford Street Project has provided this service to Probation and Public Defender. With Ford Street no longer able to provide the Sober Living Environment, Izen would like the CCP to set aside funds to be earmarked for these services, with a provider to be identified at a later date. Discussion is held regarding past budgeted amounts and the utilization. Kim Turner, Courts, motions to approve funds in the amount of \$120,000 to be set aside for Sober Living Environment, with a provider to be determined. David Eyster, District Attorney, seconds the motion. Vote taken. Motion passes unanimously.

Izen Locatelli, Probation, calls for a final motion to approve the FY 2024-25 CCP Proposed Budget, with the two changes approved today, and direct the Probation Department to prepare the required documents for presentation of the proposed budget to the Mendocino County Board of Supervisors on April 23, 2024. Kim Turner, Courts, motions to approve. Eric Rennert, Public Defender, seconds the motion. Vote taken. Motion passes unanimously.

Izen states that with the CCP's Executive Committee approval of the CCP FY2024-25 proposed budget, the additional special CCP meeting scheduled for March 21, 2024, is canceled.

## 4b) CCP Executive Committee Members Report on Items of General Interest <u>Recommended Action:</u>

Kim Turner, Courts, would like to announce the Juvenile Justice and Delinquency Prevention Commission (JJDPC) is now receiving administrative support from the Mendocino County Superior Court.
