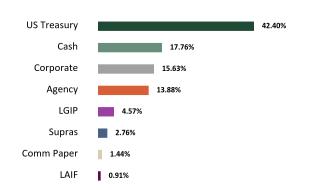

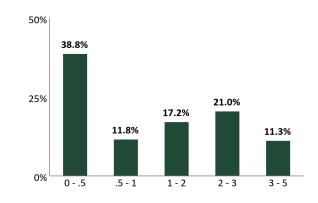

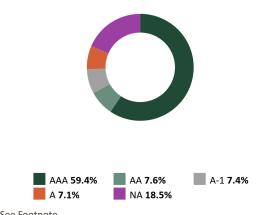
#### Sector Allocation
