3a) Approval of Minutes from the February 28, 2024, Regular Meeting.

- We have one item submitted to the Board of Supervisors since the last time we met the California Environmental Quality Act (CEQA) for the PHF that allowed them to move forward with posting the bid documents.

3d) Update and Discussion Regarding the Status of Current Measure B Projects

Presenter: Chair Ebyam

- Doug Anderson, Assistant Facility Manager, for General Services Agency.
- He informed the Measure B board members that he was currently working with the project team to develop the PHF project. A plan for bidding was issued today, and the bids are due to be opened on June 27th. They were about a month behind the proposed schedule, which would have had them completing the project in October 2025 around the same time as the jail. Member Allman inquired about the presence of any contractual provisions that would serve to safeguard the budget in the event of a change order. Additionally, they sought clarification on whether the contract includes a legal framework for the imposition of a reasonable fee for change orders, as opposed to it being the sole recourse available.
- Doug Anderson answered the contract documents, define the terms and conditions for change orders. They limit the contractor's markup on change orders to 5% over their demonstrated cost. They must provide invoices and detailed spending documents if we question the validity of a claim or change order proposal. This ensures transparency in costs, although they may still be higher than expected.

- Chair Ebyam asked Member Pierce about the terms of the repayment plan.
- Member Pierce presented a proposal to the Board of Supervisors for a 10-year loan repayment plan with a fixed interest rate of 2.5%. This proposal will be subject to the Board of Supervisors' final approval.

- Supervisor Haschak stated that Sheriff Kendall has been actively seeking financing for the project but has not found any available funding.

4a) Committee Member Reports Regarding Items of General Interest

- Member Allman has nothing to report, but he has some important points to discuss. Firstly, he recommends issuing a press release to inform the public about the use of funds for mental health, especially with Proposition One passing in the state. Additionally, he suggests retiring the phrase "measure B" for future elections to avoid confusion. Moving on, he expresses disappointment at the lack of progress in establishing a behavioral health technician course at the Community College. They need to pressure the college in to developing this training program to address local hiring challenges. The speaker proposes inviting the college president or the Vice President in charge of curriculum to the next meeting to discuss concerns about the mental health technician program. Lastly, the speaker requests to have Doug on the agenda for the next meeting. It will be post opening bids, and they need to hear about the progress directly from him. His presence and input at the meeting would be highly valuable.
