MHRB\_2024-0003 (TOM COULSON, MENDOCINO VILLAGE INN) REQUEST FOR EXTERIOR ALTERATIONS AT THE EXISTING MENDOCINO VILLAGE INN, INCLUDING THE CHANGE OF EXTERIOR PAINT COLORS, REBUILD DETERIORATED WOOD FENCING, RELOCATE EXISTING WATER TANKS AND INSTALL SCREENING, REBUILD THE FRONT PORCH AND STAIRS TO MATCH EXISTING WITH EXCEPTION OF PAINT COLORS, REPLACE EXISTING HANDRAILS WITH NEW METAL HANDRAILS AND REMOVE TWO (2) EXISTING FIREPLACES AND CHIMNEYS AND REPLACE THE CHIMNEYS WITH BRICK VENEER TO MATCH THE EXISTING CHIMNEY DESIGN (NOTE: THE SITE IS DESIGNATED A CATEGORY I HISTORIC RESOURCE.
